Each shareholder is entitled to attend in person at the Shareholders' Assembly, and for the same are obliged to register their presence before the start of the Assembly at the latest. Each shareholder may appoint another person who will represent him/her at the Shareholders' Assembly and may vote on his/her behalf. The authorized person should have a written Power of Attorney.

The shareholder who will not inform the Company for the given authorization shall be deemed as he/she has not issued any.

Persons with conflict of interests may be appointed as representatives for the Assembly, only on the condition that they have previously disclosed to the shareholders is a conflict of interests and that the shareholder gave specific voting instructions in writing for each suggested items on the agenda for the session of the Assembly for which the authorization is valid for.

The Assembly shall decide only for issues that have been duly placed on the agenda according to the Statute of the Company and the Trade companies Law.

The shareholders that individually or jointly own at least 5% of the total number of the voting shares can request amendment of the agenda by adding new points provided that they simultaneously provide an explanation for the proposed point that is to be added on the agenda or if they propose a decision upon a proposed point, as well as to propose in writing the adoption of decisions on each of the items that are included or will be included in the Agenda.

The inclusion of new items on the Agenda may be made in writing in a manner provided by Article 390 of the Trade Companies' Act, within 8 (eight) days from the day this invitation is published.

The shareholders and their representatives who shall participate at the Assembly will register at the Company's Archive or by telephone at 02/2786-135 for the sake of evidence.
